MATERIAL NON-PUBLIC INFORMATION ADMINISTRATION SERVICES (MNPI)

In an effort to assist our clients manager their unique compliance and MNPI segregation needs, Alter Domus developed a process to effectively shield a client from the receipt (direct or inadvertent) of MNPI. Additionally, Alter Domus' solution provides a review and filter of any relevant MNPI that may lead to (i) a trading decision or (ii) potential receipt of amendment fees. The two services, Amendment Administration and MNPI firewall service, together constitute a best practices approach to the segregation and isolation of MNPI while providing for prudent credit decisions related to amendments and associated fee income opportunities.

The MNPI Firewall service includes:

- Alter Domus becoming named credit contact for all loans in the portfolio
- Alter Domus screening all information received via the private channel to assess the type, quality and relevance of such information with an eye toward what types of credit decisions may need to take place with the client's purview
- Acting on certain amendments, as provided for within guidelines established by the client at the outset of the engagement
- Liaising with approved contact points of the client in situations deemed to warrant communication regarding certain private information—e.g. compliance officer, legal officer, etc.
